### TOURIST TAX

## GENERAL INFORMATION FOR GUESTS

The Municipality of Ozzano dell'Emilia has established the "tourist tax" by resolution of the City Council no. 79 of 21/12/2023, effective from 1st April 2024.

### PURPOSE OF THE TAX

The tax is intended to finance interventions of tourism sector, including those in support of accommodation facilities, maintenance, use and recovery of local cultural and environmental assets, as well as the related local public services (art.4 Legislative Decree 14/03/2011, no. 23).

### WHO PAYS THE TAX

The non-resident people in the Municipality of Ozzano dell'Emilia who stays overnight in one of the accommodation facilities in the municipal territory, referred to in the legislation of the Emilia-Romagna Region on tourism (including properties intended for short-term rental referred to in art.4 , paragraph 5-ter, of Legislative Decree 24/04/2017, converted with amendments by Law 21/06/2017, no. 96).

The tax must be paid to the accommodation facility, who issues a specific receipt. Anyone who fails to pay is subject to the sanctions provided for by current regulations.

### HOW MUCH YOU PAY

The tax is due per person and for each night of stay up to a maximum of 5 consecutive nights. The maximum threshold of 5 consecutive nights is valid only when the stay is carried out at the same accommodation facility.

In the case of repeated and systematic overnight stays within the same calendar month, the tax applies limited to the first 5 nights.

Tourist tax rates based on the cost of the room	
<i>Cost of the room with breakfast (net of VAT and any additional services)</i>	<b>Rate per person/night</b>
From euro 1,00 to 70,99	€ 1,00
From euro 71,00 to 120,99	€ 1,50
From euro 121,00 and up	€ 2,00

### EXEMPTIONS

In addition to residents of the Municipality of Ozzano dell'Emilia, the following people are exempt from paying the tourist tax:

a) children up to 14 years old;

b) university students regularly enrolled at the University of Bologna;

*The exemption applies only upon presentation of the University registration certificate that the guest is required to present to the Municipality through the accommodation facility;*

c) people staying for medical consultations, treatments or therapies in day hospital (day surgery/day service) at healthcare facilities in the metropolitan area of Bologna, as well as people who care patients hospitalized in healthcare facilities in the metropolitan area of Bologna, for a maximum of one assistant per patient, limited to overnight stays falling within the period of hospitalization or therapy, including the overnight stay immediately prior to hospitalization or therapy;

*The exemption applies exclusively upon presentation of a specific certification from the healthcare facility (certifying the patient's personal details and the reference period of the healthcare services or hospitalization) that the guest is required to present to the Municipality through the accommodation facility;*

d) people who have been accommodated in accommodation facilities by the Municipality of Ozzano dell'Emilia or by other public entities as part of their institutional activity, to deal with social or social-welfare emergency situations;

e) people staying in accommodation facilities following measures adopted by public authorities, to deal with social and emergency situations resulting from calamitous or extraordinary events or for humanitarian relief purposes;

f) people and rescue volunteers (coordinated by public authorities) staying in accommodation facilities due to natural disasters, or extraordinary social emergencies;

g) bus drivers, professional tour leaders and tour guides who provide assistance to tour groups organized by travel and tourist agencies;

h) people serving the Police Force and the Armed Forces, staying for service purposes only, limited to the period of service itself;

*The exemption applies exclusively upon presentation of a specific declaration from the competent public authority (certifying the personal details of the guest and the period of stay) that the guest is required to present to the Municipality through the accommodation facility;*

i) people staying for the hospitalization of pets at veterinary healthcare facilities in the municipal area, for a maximum of one assistant per animal, limited to the overnight stays falling within the hospitalization period, including the overnight stay immediately prior to hospitalization.

*The exemption applies exclusively upon presentation of a specific certification from the veterinary healthcare facility (certifying the guest personal details, the animal's identification data and the reference period of hospitalization) that the guest is required to present to the Municipality through the accommodation facility.*
